## **JOB DESCRIPTION**

### **General Summary/Objective**

Under limited supervision, Work in a crew to perform operation and maintenance of the water distribution system. Perform line installation and repair, locate lines, and detect leaks. Operate machinery, tools, and equipment. Set water meter, maintain, and repair fire hydrants. Observe standard safety precautions and practices.

### **Essential Functions**

1. Perform general maintenance and installation of water lines.
2. Locate lines, excavate, and repair lines.
3. Perform meter checks, tests, and verify meter readings.
4. Repair, replace, or set water meters.
5. Repair customers yard/landscaping when required.
6. Replace valves, and meter boxes.
7. Maintain fire hydrants and make repairs when needed.
8. Interact with vendors, employees, consultants, and customers.
9. Operate and perform general maintenance of equipment such as power and hand tools, backhoe, ditch witch, air compressor, dump truck, etc.
10. Grass cutting

### **Supervisory Responsibility**

**Work Environment**

While performing the duties of this job, the employee works outdoor in all weather conditions. The work environment includes loud noise, water, mud, grease, oil, dirt and other related conditions, operate and work around a variety of equipment and machinery, working in ditches, on inclines, uneven surfaces, and banks.
