### JOB DESCRIPTION

#### General Summary/Objective

Under general supervision, perform operation and maintenance of the wastewater collection system.

#### Essential Functions

1. Work in a crew to assist in general maintenance of the wastewater collections system.
2. Locate wastewater collections line and manholes, excavate and repair lines when needed.
3. Check and maintain pump stations and various equipment and make repairs when needed.
4. Repair customer's yard/landscaping when required.
5. Record charts change charts and keep accurate logs.
6. Observe standard safety precautions and practices.
7. Follow state and federal laws and regulations.
8. Operate and perform general maintenance with equipment including power and hand tools, lawn equipment, backhoe, ditch witch, air compressor, jackhammer, jet truck, dump truck, truck, and trailer, etc.
9. Responsible for keeping wet wells clean by using chemicals or jet truck.
10. Interface with customers on complaints and inquiries.
11. Interface with contractors and assists with line locations.
